A cover letter stating your willingness to take up this “Apprenticeship Training Programme” is a must.
- The candidate should be a resident of Meghalaya and should not be less than 18 years and not more than 32 years of age as on 1.01.2025. Upper age limit is relaxable by 5 (Five) years for Scheduled tribe, Scheduled tribe, OBC and PWD candidates.
- Applicants appearing with incomplete documents will not be entertained for the apprenticeship programme.

2. Selection

- Selection based on merit as per mark secured in the degree/diploma course would be one part of the selection process.
- Personal Interview.

3. Terms and Condition

- The candidates will be awarded stipend as per the Organizational policy.
- The candidate should have 90 % of the attendance in 6 (Six) months of the Apprenticeship Training Programme.
